AT MERIDA, MEXICO. CARBALLO ADVISED THE SOURCE RECENTLY THAT ABOUT TWO MONTHS AGO REPRESENTATIVES OF THE CENTRAL INTELLIGENCE AGENCY (CIA) APPROACHED HIM AND THREE OTHER CUBAN EXILES AND INFORMED THEM THAT CIA WAS DISSATISFIED WITH ALL THE ACTS OF SABOTAGE BEING CARRIED OUT AT RANDOM AND ORDERED THEM TO DISASSOCIATE THEMSELVES FROM BOSCH AND CORU. REPORTEDLY, THROUGH THE EFFORTS OF SOMOZA, BOSCH HAS BEEN PLACED UNDER "HOUSE ARREST" TO PREVENT ANY FURTHER ACTIVITIES ON HIS PART. IN THE MEAN TIME, DURING THE WEEK OF SEPTEMBER 12 - 18, 1976, CARBALLO, ARTIME, MANUEL CAMARGO OF MEXICO CITY, AND ANOTHER UNIDENTIFIED CUBAN EXILE HAVE BEEN IN WASHINGTON, D. C. CONFERRING WITH REPRESENTATIVES OF THE CIA ON PLANS TO BE CARRIED OUT BY THE ACTION ARM OF THE AVBC. SOURCE WAS UNAWARE OF THE EXACT PLANS, HOWEVER, KNEW THAT THE ACTION ARM WAS TO CARRY OUT ATTACKS INSIDE AND OUTSIDE OF CUBA. FINANCING OF THE ACTION ARM WILL COME FROM CIA. (S)(u)

BUREAU ATTENTION IS DIRECTED TO CURRENT CASE INTITLED, "ORESTES RUIZ HERNANDEZ, AKA; ET AL; ATTEMPT TO KIDNAP CUBAN CONSUL, MERIDA, MEXICO, JULY 23, 1976; DANIEL FERRER FERNANDEZ-VICTIM, NEUTRALITY MATTERS - CUBA - MEXICO" (BUFILE 105-303095) IN WHICH ALLEGATION MADE BY MIAMI SOURCE THAT MEXICO CITY DEA AGENT OMAR ALEMAN TOOK ACTIVE ROLE IN ANTI-CASTRO BOMBINGS AT SOVIET AND CUBAN EMBASSIES DURING NOVEMBER, 1975. BUREAU AIRTEL DATED SEPTEMBER 2, 1976 IN THIS MATTER DIRECTED MIAMI TO IDENTIFY CORU MEMBERS WITH WHOM ALEMAN HAD CONTACT IN ORDER THAT THESE NAMES COULD BE PROVIDED DEA. MANUEL CAMARGO IS DEA INFORMANT HANDLED AT MEXICO CITY BY ALEMAN AND IS THE ACKNOWLEDGED HEAD OF ALL ANTI-CASTRO, INCLUDING CORU, ACTIVITIES IN MEXICO. IN EVENT CAMARGO'S PRESENCE IN WASHINGTON, D. C. CAN BE VERIFIED [THROUGH CIA HEADQUARTERS,] HE SHOULD BE IMMEDIATELY INTERVIEWED REGARDING ALLEGATIONS AGAINST (S)(u)
