On 12/15/66, [the Direction de la Surveillance du
Territoire (DST), French domestic counterespionage service] (S)
and [CIA, Paris] (S) were alerted to our interest in subjects.
On 12/23/66, [the Policia Internacional e de Defesa de Estado
(Portuguese International and State Security Police - PIDE),
Lisbon, Portugal] (S) and [CIA, Rabat, Morocco, (through CIA,
Paris)] (S) were requested to furnish any available information
regarding subjects' activities.

Since referenced airtels indicate subjects have
returned to New York and our sources are alerted to our
interest in this case, it is being RUC'd. In the event
additional information is received, it will be furnished.

Re New York airtel 1/16/67, [British Security Service, MI-5, by letter dated 1/23/67] advised the following:

RICHARD FRANK arrived in London on 12/14/67 and stayed at the Normandie Hotel, 163 Knightsbridge, S.W. 7, where he was joined by his wife on December 21. They were both in London on the following day (TS)

A very delicate and reliable source has reported that RICHARD FRANK was in touch with WILLIAM ASH, who made arrangements for FRANK to contact a representative of the New China News Agency in London. ASH assured the NCNA representative of FRANK's reliability (TS)

MI-5 does not know whether FRANK and the NCNA representative subsequently met (TS)

The FRANKS left their hotel on December 25 and it is possible that they may have departed from the UK on that date. This has not been confirmed (TS)

For Bureau information, it is noted that complete background on WILLIAM ASH was furnished the Bureau as an enclosure to London letter dated 11/18/66. Bufile 100-339235. SUSAN HEILIGMAN FRANK.
