On 10/29/64, LES 847-S, who is familiar with SNFE activities in the Eight area and who has furnished reliable information in the past, furnished the following information which he obtained from RUBEN VARMA, close friend of ANTONIO VECIANA BLANCH. Treasurer of the SNFE, Alpha 66:

Two fairly good sized boats, which belonged to JURE, were delivered by JURE leader MANUEL RAY RIVERO to the SNVE-Alpha 66. These boats were delivered in Puerto Rico and ANTONIO VECIANA was present at the time of delivery. Alt is not known whether the boats were purchased or loaned.

In HH 847-S advised on 10/9/64 that VECIANA would the going to Puerto Rico shortly.

As it appears that VECIANA is now im Puerto Rico. San Juan, is requested to alert appropriate sources in order to provide coverage of VECIANA's activities there. For additional information of San Juan, [CIA, High, furnished information on 10/0/64 to the effect that VECIANA was attempting to obtain a motorboat for use in an attack against a British merchant vessel.] No additional details were available [5-1] as to the identity of the target or as to the date or participants in the planned raid/salex.
