On 10/29/64, NM 847-S, who is familiar with SNFE activities in the Miami area and who has furnished reliable information in the past, furnished the following information which he obtained from RUBEN VARELA, close friend of ANTONIO VECIANA BLANCH, Treasurer of the SNFE, Alpha 66:

Two fairly good sized boats, which belonged to JURE, were delivered by JURE leader MANUEL RAY RIVERO to the SNFE-Alpha 66. These boats were delivered in Puerto Rico and ANTONIO VECIANA was present at the time of delivery. It is not known whether the boats were purchased or loaned.

NM 847-S advised on 10/9/64 that VECIANA would be going to Puerto Rico shortly.

As it appears that VECIANA is now in Puerto Rico, San Juan, is requested to alert appropriate sources in order to provide coverage of VECIANA's activities there. For additional information of San Juan, [CIA, Miami, furnished information on 10/8/64 to the effect that VECIANA was attempting to obtain a motorboat for use in an attack against a British merchant vessel.] No additional details were available as to the identity of the target or as to the date or participants in the planned raid.
