On 2-13-74, SJ 492-S advised that he had no information concerning this matter but that he would attempt to obtain information. He stated that he is acquainted with [redacted] and that [redacted] would in all likelihood contact him if he came to Puerto Rico. He stated that he had not seen or heard from [redacted] for several months.

On 3-1-74, SJ 492-S advised that he had been unable to obtain any information concerning "The Pope Speaks." He stated that he is certain that there is no such organization as United Cubans (Cubanos Unidos) in Puerto Rico. He also stated that he was unable to find any information concerning WILFREDO NAVARRO or GORDON DI BATTISTO. He stated that he did know that [redacted] was in favor of preaching the Cuban cause to the American people but that he did not know of any specific program that [redacted] had in this regard. He stated that he would be alert for any information concerning the above and would immediately report any information that came to his attention to the FBI.
