THE CUBAN GOVERNMENTINTENDS TO EXECUTE BOSCH AND POSADA, EITHER WITH OR WITHOUT DUE PROCESS OF THE LAW.

DESPITE HIS YEARS IN EXILE, BOSCH IS CONSIDERED BY THE CUBAN GOVERNMENT TO BE A CUBAN CITIZEN, HERNANDEZ SAID, AND THE CUBANS WILL REQUEST THAT HE BE TURNED OVER TO THEM FOR PROSECUTION. IN THE CASE OF POSADA, HERNANDEZ SAID THAT THE CUBAN GOVERNMENT WILL REQUEST THE VENEZUELAN GOVERNMENT TO REVOKE HIS VENEZUELAN CITIZENSHIP AND THEN TURN HIM OVER TO CUBAN AUTHORITIES. IF THEY WERE TURNED OVER THROUGH LEGAL MEANS, HERNANDEZ SAID THAT BOTH BOSCH AND POSADA WOULD BE GIVEN A QUICK TRIAL IN CUBA AND THEN EXECUTED WITHIN THREE HOURS.
