1. Reference is made to your New York Field Office memorandum dated 25 January 1966, captioned as above. The following amplifies information orally passed your Bureau via liaison on 17 February.

2. On 26 January, SUGAR was contacted in at his hotel by a woman calling herself Lisa ARMAND. Subsequently having the opportunity to check the hotel register, he found that a woman was also registered as a Mrs. FRANK, travelling on a U. S. (C) passport. Since the call from "Lisa ARMAND" was an inside call, he assumed that this was a name being used by Mrs. FRANK. The hotel in question is frequented by communists and particularly by foreign communist elements having dealings with pro-Chinese Communist Party.

5. SUGAR and Subject were joined by Rene RAINDORF and Michael GRAINDORGE, secretary of GRIPPA's youth group and now a lawyer! ARMAND outlined the case of EPTON to them and urged them to get statements on EPTON's behalf from all possible quarters, especially lawyer's associations.
