The letterhead memorandum is classified "Confidential" since it contains information from CG 5824-S\*, a highly placed informant.

The NYO is of the opinion that the subject's sudden plan to depart the US may be significant, especially in following her activities after her return to the US. It is believed that in all likelihood she may again travel to China since NY 4047-S\* advised that she contacted the Czechoslovak Mission to the United Nations. It is to be noted that prior to her last trip to China, she went to Prague, Czechoslovakia. (u)

WFO is requested to contact and maintain liaison with the US Department of State to discreetly determine subject's date and mode of departure from the US.

The Bureau is requested to contact, through liaison [redacted] and the Legat, London, and have them attempt to discreetly determine subject's contacts and activities in England and elsewhere. The Bureau will be advised of any further details developed as to the subject's departure and itinerary.
