REQUESTS OF BUREAU

It is suggested that the Bureau request the Legat, Havana, to conduct the following investigation concerning the expedition of the "Corinthea": X(u)

(1) Will interview LAZARO EUGENIO GUERRA CALDERON and MARIO RODRIGUEZ ARENAS, who can undoubtedly be located through SIM and will obtain signed statements, if possible, concerning their knowledge and willingness to testify concerning the expedition of the "Corinthea" and particularly the alleged meeting which was addressed by PRIO immediately prior to departure of the "Corinthea". X(u)
