CHAPUT RELATED THIS SOURCE SAID TWENTY EIGHT INDIVIDUALS SCHEDULED PARTICIPATE IN INVASION AGAINST CUBA, BUT FIORINI HIMSELF WOULD NOT GO. TWO M DASH ONE RIFLES AND TWO CARBINES WERE SHOWN TO THIS SOURCE BY FIORINI, AND SOURCE SAID THESE MEN ARE BEING TRAINED IN RIFLE PRACTICE IN THE EVERGLADES.
