Files of Legat, Bern, have been reviewed for individuals residing in Switzerland and Austria considered to be a possible threat to the President, and no one was found to fit this category.

In addition, discreet inquiry was made of the following sources, all of whom had no knowledge of individuals who might be considered threats:

Office of Special Assistant
the Embassy, Bern;
American Consulate General, Vienna;
Research Branch
Vienna;
Security Officer, the Embassy, Vienna.

In this regard, however, Bureau attention is called to the case entitled PAUL GEORGE ANDERSON, aka, IS-X (Buffle 100-415051). ANDERSON has been reported to be of interest to the Secret Service (Legat, Paris, letter dated 10/16/64). While he does not reside in territory covered by this office, he is in rather frequent transit en route to Hungary, where he is attempting to obtain a visa for his Hungarian wife to enter the U.S.
