Reference is made to your letter dated 9/28/61 advising that the Central Intelligence Agency (CIA) activities in Miami will be operating under the cover name of Zenith Technical Enterprise.

For your information, CIA has advised that its Miami operations which were directed against the Cuban Government are being completely revamped. Consideration is being given to the use of the referenced cover but no final decision has been made. The entire matter is under study.

This matter is being closely followed with CIA and all interested offices will be furnished with details as soon as they are received from CIA. You should continue to keep the Bureau advised of any developments coming to your attention.

With regard to [redacted] CIA employee mentioned in referenced communication, Bureau records are negative. Information has been developed disclosing that he is assigned to the Office of Security, CIA, and his duties would relate to physical and personnel security.

**NOTE:** Liaison has been following with CIA regarding reorganization of that Agency's operations since the Cuban fiasco. By letter dated 9/28/61 Miami reported information received from a CIA employee indicating that reorganization was going into effect under the above-described cover. Copies of communication being disseminated for San Juan and Mexico City since aspects of CIA's planning possibly could come to the attention of those offices.

SUBJECT: CIA OPERATIONS - MIAMI AREA

*Central Intelligence Agency*

For the Bureau's information, RICHARD KING, who has been in charge of CIA covert operations in Miami, has advised that within the near future he will be reassigned to Washington. WILLIAM McCLARE, who has been assigned to the Miami area for some time, will be in charge.

Another CIA Agent named [redacted] <sup>(S)</sup> will be *FLORIDA* assigned to Miami in the near future. The Bureau is requested to furnish any information in its files regarding [redacted] <sup>(S)</sup>

CIA operations in Miami will henceforth operate under the cover name of Zenith Technical Enterprise and be located in Building 25, South Campus, University of Miami. *FLA* The CIA men assigned will be known as Department of Defense employees working on the premises for the purpose of inspection.

For the Bureau's additional information, Mr. KING has advised that CIA operations at the present time in this area are limited to engaging in clandestine maritime operations against Cuba, including contact with and supply of underground elements in that country. Each individual clandestine operation must be previously approved by RICHARD BISSELL, Deputy Director of Plans, CIA, Washington, D.C.
