United Press International wire service report dated August 17, 1963, advised that "three U. S. trained spies" were executed on August 16, 1963, in Cuba. The official Cuban account reported that the three were identified as "Rolando Mathew Paz and brothers Francisco and Manuel Marrero Castillo." They were reportedly caught on July 22, 1963, trying to slip into Cuba with arms, material for secret writing, and "instructions from CIA to organize spy nets and sabotage against the national economy."

On August 19, 1963, Mr. [] CIA, advised the [] Liaison Agent that the above three individuals were under the control and in the employ of CIA at the time of their arrest by Cuban security forces.
