He was given authority to disseminate to the FBI on all matters of interest to us. In 1953 we worked out an agreement where Angleton disseminated 02 DECLASSIN RELEASE to us, and we attributed the information to Bureau Informant 100. HAS The field was given appropriate instructions regarding the handling and reporting of the information. This procedure is CIA still in existence and is operating satisfactorily. The information disseminated by Angleton is filed in the case file of an individual or an organization.
