CIA MIAMI TODAY ADVISED THAT ON SIX FOURTEEN SIXTYTHREE, THEY  
RECEIVED INFORMATION THAT CAPTIONED ORGANIZATION IS RUMORED TO BE  
PLANNING A RAID AGAINST THE NORTH COAST OF CUBA, SOMETIME BETWEEN  
JUNE, FOURTEEN AND JUNE, TWENTY, SIXTYTHREE. THE TARGET IS AT  
THE BOUNDARY LINE OF MATANZAS AND HAVANA PROVINCES. (u)

CIA SOURCE IS [REDACTED] WITH INTIMATE KNOWLEDGE

OF MARATIME ACTIVITIES IN FLORIDA. THIS SOURCE RECEIVED THE  
INFORMATION FROM A PERSON WHO HAS CONTACT WITH CUBAN MILITARY AND  
POLITICAL GROUPS IN MIAMI. CIA SAID THEY WILL NOTIFY U. S. CUSTOMS. (u)

ANTONIO PEREZ QUESADA, A FISHERMAN WHO IS IN COMANDO L ACTION GROUP,  
WHO HAS BEEN COOPERATIVE IN THE PAST, AND HAS PARTICIPATED IN RAIDS,
