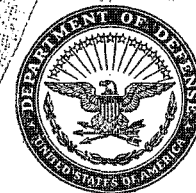

Dear Sir

1. Reference is made to your report, subject as above, #105-2118, dated 17 February 1961, which reflected that Subject was located at the Alien Detention Facility, McAllen, Texas.

2. Recently, CIA advised this Headquarters that, according to [redacted] Subject had contacted one Lindsey Ling, aka: Ling Lind Sey, DPOB: 12 March 1919, in Chekiang, China, in late August 1960 in Santa Maria, the Azores. Ling currently resides in Madrid where he manages a restaurant allegedly owned by another unidentified Chinese who reportedly has supplied clothing to US personnel at Lajes Base in the Azores. Ling is one of several Chinese subjects who are suspected of using their business ventures as a cover for espionage or other illegal activities. The CIA report also reflects that one Theodor Heinz Wiener, who had represented the clothing firm in the Azores, was reportedly arrested there in December 1958 on suspicion of espionage, and was, as of September 1960, reportedly in Bermuda, where Ling was planning to go to determine the feasibility of establishing another restaurant.

3. It is requested that Subject be questioned concerning the nature and extent of his association with Ling and other Chinese, and that this office be advised of any information which may reflect espionage or other illegal activities affecting USAF interests. His possible association with Wiener also should be explored.
