ANTONIO RODRIGUEZ ECHAZABAL, IS - CUBA. SUBJECT ARRIVED
 SAN JUAN, PUERTO RICO APRIL 6 ABOARD AIR FRANCE FLIGHT
 990 FROM GUADALUPE, FRENCH WEST INDIES. SUBJECT ACCOMPANIED
 BY 19 YEAR OLD SON ANTONIO GUILLERMO RODRIGUEZ JONES.
 SUBJECT ADVISED IMMIGRATION AND NATURALIZATION INSPECTOR
 AT SAN JUAN THAT HE WANTED TO BE PUT IN CONTACT WITH
 UNITED STATES INTELLIGENCE AGENCY PREFERABLY CENTRAL
 INTELLIGENCE AGENCY. INS ADVISED THIS OFFICE AS WELL AS
 LOCAL CIA REPRESENTATIVE. CIA REPRESENTATIVE STATED HE
 WOULD LEAVE ORIGINAL CONTACT UP TO THIS OFFICE UNTIL IT
 DETERMINED SPECIFICALLY WHAT TYPE INFO SUBJECT HAS OR
 PURPOSE OF VISIT TO PUERTO RICO. SUBJECT INTERVIEWED
 APRIL 6 AT HOTEL NORMANDIE, ROOM 526, SAN JUAN. SUBJECT
 STATES HE WANTS TO BE PUT IN IMMEDIATE CONTACT WITH CIA.
 JURISDICTION OF FBI AND CIA EXPLAINED AND SUBJECT STATES
 HIS INFO CONCERNS EXTERNAL MATTERS AND NOTHING REGARDING
 INTERNAL SECURITY OF UNITED STATES. SUBJECT STATES HE
 IS PRESENTLY SECRETLY WORKING WITH FRENCH GOVERNMENT IN
 GUADALUPE WHO DO NOT WANT HIM TO CONTACT UNITED STATES
 INTELLIGENCE AGENCIES. FRENCH GOVERNMENT SUPPLYING HIM
 WITH HOUSE, AUTOMOBILE, AND EXPENSES. SUBJECT ADVISED
 FRENCH AUTHORITIES PURPOSE OF TRIP TO PUERTO RICO IS TO
 OBTAIN MEDICAL TREATMENT FOR CATARACTS. FRENCH AUTHORITIES
