On February 27, 1961, Cliff Carrico, Office of Security, Central Intelligence Agency (CIA), advised that the following information had been received from a Cuban refugee source of unknown reliability. (S)(u)

The subject reportedly served as a Secretary to Castro and recently arrived in Miami. The source advised that subject has been in contact with Hector Garcia, whom the source characterized as a "Castro agent." The source further indicated that subject is well known to Cubana Airline pilots. (S)(u)
