The subject is an intelligence officer employed by CIA for the past several years. He has served for CIA in Spain, Cuba and Argentina and is presently assigned to CIA headquarters, Washington, D. C. On 3/24/59 a representative of CIA advised that as a result of service in Cuba, the subject knows several Cuban Government officials. The CIA representative stated that the subject has been in touch with Lieutenant Commander Pons, Naval Attache, Embassy of Cuba, and that the subject has known Pons for several years. The subject's contacts with Pons was of a social nature. The CIA representative advised that the subject is not involved in any intelligence operation with the Cubans.

The above is for your information. No further investigation is desired in this matter in view of Gomez's employment by CIA. (u)
