

"During his New York City tenure, he was known to write bank drafts to persons known to be active Communist \ workers. It was suggested that he was used as a means of financing Communist Party activities." (\mathcal{L}) (\mathcal{U})

CIA stated above conclusion "was apparently based on numerous Bureau reports written during 1957 and 1958."
