For your information, CIA on 8/16/61 advised that on occasion CIA has utilized PSI [redacted] This material has dealt with CIA operations in Cuba. (S) (U)

Be alert for possible conflict of interest between Bureau and CIA and, if CIA's occasional use of subject in any way conflicts with Bureau's interest, immediately furnish full details and your comments, observations, and recommendations. (S) (U)

During contacts with PSI, endeavor to determine, without revealing the above CIA information, whether he is in contact with any other agency. In this connection, PSI has been connected with MRP which was of operational interest to CIA. It is possible PSI, in his activity for the MRP, was actually doing work for CIA without knowing it since CIA frequently operated in organizations, such as MRP, through cutouts. (S) (U)

**NOTE:** PSI is Cuban employed as comptroller for Cubana Airlines, New York. He has been associated with MRP, anti-Castro organization, and has furnished New York with information concerning the MRP and Cubana Airlines, including the manifests of Cubana Airlines. Investigation of subject's background has been favorable.
