It is believed that the above Robert Snowden is identical to Robert LA Snowden, undertaker, whose current address according to the local telephone directory is 246 North Washington Street, Rockville, Maryland,

1(\$) born 29 May 1916, a current Agency employee, listed Robert Snowden, 246 North Washington Drive, Rockville, Maryland, as a reference in 1952, and a copy of his undated Personal History Statement is attached. **(\$)**.

The son_of born 25 April 1940, BISO LISted Robert L. Snowden. 246 North Washington Street, Rockville, Maryland. as a reference on an 11 March 1957 Personal History Statement. was a summer employee of this Agency in 1957. It is not known at this time whether either are known to Richard Thomas Gibson.

In view of the above information, it would be appreciated if your Bureau would furnish this Agency any information contained in your files in regard to the Robert Snowden listed as a reference by Richard Thomas Gibson and/or the Robert L. Snowden listed by

andyson as a reference.
