It is noted that referenced letter points
out to CIA that subject desired to be contacted by
CIA, preferably in Montreal, Canada. *(S)*

It is noted that subject had no known source
of funds at the time he was interviewed by Agents of
the NYO on 8/16/62, although on 9/12/62, he departed
New York allegedly for Canada, and from there went to
Algeria. *u*

In view of the above, it appears possible
that subject may have been contacted by CIA and may
in fact, be working for CIA in some capacity at the
present time. *(S) u*

*Austin Horne, CIA advised that
his agency did not contact
subject and doesn't plan
to do so.* *(S) u*
