Contact with San Juan sources familiar with various aspects of the Cuban exile activities in Puerto Rico during August, September and October, 1973, has failed to develop any positive information regarding the subject's activities. Sources contacted indicated that subject has not been in Puerto Rico during the above period and also, sources are aware of his arrest on drug charges in Miami. Sources also advise VECIANA was formally active with and the cofounder of Alpha -/66, det severed his relationship several years ago. Recently, WECTANA was a member of the Partido Revolucionario Del Pueblo (Revolutionary Party of the People) (PRP), but severed his relationship with this organization in the early summer of 1973, when he left the PRP claiming it lacked "revolutionary zeal."
