MEMORANDUM FOR THE ATTORNEY GENERAL  
RE: JOSE ANTONIO GONZALEZ-GONZALEZ  
ESPIONAGE - CUBA

The subject is involved in Puerto Rican independence activities in New York City and recent developments in a Cuban agent network operating in Puerto Rico have indicated that the subject is involved in this network and is possibly the link between the Cuban United Nations Mission in New York City and key Cuban agents in Puerto Rico. The subject is closely associated with Juan Mari Bras who was the subject of our memoranda to you dated September 30, 1963, and January 21, 1964. Mari is the leader of the Cuban agent network in Puerto Rico.

In order that additional information may be developed regarding the subject's activities and contacts, it is requested that you authorize [redacted] coverage on his present residence or at any address to which he may move in the future. The subject presently resides in a fourth floor apartment at 58 West 88th Street, New York City, and is a part-time lecturer at Queens College, Queens, New York City.

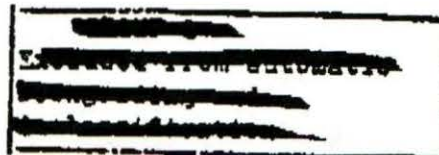
It is requested that the information regarding the subject's involvement in the Cuban agent network be treated in the strictest confidence [redacted] (T.S.)
