Further review of our files has shown that CIA employee did not use any cover provided by Mr. Maheu or his firms for the TDY to India, Thailand and Malaysia in 1960. CIA employee's TDY cover was backstopped by [redacted] who, at a later time, was employed by Robert A. Maheu.
