1. Subj. reports has received four-month tourist Soviet visa and plans depart via air next two weeks. Upon arrival Moscow will explore job posses ~~misses~~ opportunities. Plans take boat via Riga.
2. Subj. has agreed "Embassy" briefing prior departure. Expressed willingness do what could during time Moscow. Status not pursued since subject not yet cleared.
3. Subj. has some friends whom will contact upon arrival, all from intellectual and artistic circles. Believe after careful briefing subj could act as spotter and might contact appropriate Soviets of interest Kubark. Also letter mailing.

Purpose of Bad Godesberg visit is to discuss her future w/ Ed Faetermayer, Boss correspondent of Wall Street Journal, who old acquaintance (Barbara R. Canfield), who acquainted w/ Faetermayer, will see Johnson. Although doubtless HQ will doubtless wish debrief her upon return to States, (Canfield) could arrange for introduction of (FROB) officer for social and exchange of views meeting in Bad Godes
