Cellini's 201 has the inclusive dates of 1971-1975. The file status is closed. The review form is dated 9 Jan 1975. The file contains a dispatch to the [redacted], dated April 1971 regarding Headquarters Trace Results on Dino Vincent Cellini.

The document includes the following statements:

- 1- Dino Cellini is mentioned in [UFGW-157], 15 Dec 1961, but unable to locate this document
- 2- 13 Feb 1961 cable stating Jose Joaquin Sanjennis Perlomo ~~REPORTED~~ reported Cellini worked at the Tropicana and Riviera in Cuba before going to ~~Haiti~~ Haiti. Subj (Cellini) now residing 12459 Key Stone Rd., North Miami.
- 3- 18 Jan 1966 report that Cellini is a well-known Washington DC gambler and "is or was a close friend of D.C. gambler Joseph Francis Nestini."
- 4- Refers to a True magazine article, April 1970 pp 83, 87 and [ENERGO] reports dated 21 Dec 1960; 18 Jan 1961; 10 July 1971.

Volume 1 of the Varona file covers from 15 Oct 1948 to Sept 30, 1949 and ~~consists~~ primarily consists of third agency material.

Volume 2 covers the period from Jan 1956 to April 1960. This file includes a biographical information form, dated 8/8/1957. Varona's DOB is 11/25/1908. POB is Camaguey, Cuba. Carlos Prio Socarras is listed as a friend of Varona's. His wife is Emilina Russ Sanchez de Varona, and his children are Carlos Manuel de Varona, and Segura Bustamente nee de Varona. He has one brother whose name was not given. Varona has been active in the political affairs for the Cuban Revolutionary Party (PRC - Autentico) since 1934.

Chronologically:

- a) 1940-44 = member of House of Representatives (Cuba)
- b) 1944-48 = member of Cuban Senate
- c) 1948-50 = Prime minister and Senator in Prio gov't
- d) 1950-52 = President of Cuban Senate.

On Aug 8, 1957 a cable from Havana stated that the PRG part 1 is attached and part two is coming. On January 27, 1958 Varona was given a 201 number and assigned a cryptonym. [On Jan 20, 1958] Varona was ~~gr~~ granted operational approval. (requested 22 Aug 1957).

On August 27, 1959, a request was submitted to amend Varona's operational approval to permit his use as a <sup>Foreign Intelligence reporting asset.</sup> "willing political action agent" in the [REDACTED] Project.

On March 10, 1960, ~~varona~~ a cable indicates Varona desired to speak to "accredited" U.S. Gov't person re "his position and plans." The Havana station recommended that [REDACTED]<sup>03</sup> "who knows Varona be authorized pass invitation to Varona for stateside conference with appropriate persons or have [REDACTED]<sup>3</sup> return soonest for cold turkey talks with Varona."

In ~~on~~ March 17, 1960, <sup>cable</sup> Jorge Alonso Pujol told [REDACTED]<sup>03</sup> on March 15 that Varona is "ready to join the active opposition to Castro. Pujol was Varona's partner in the insurance business."

In a cable dated March 25, 1960, headquarters listed ~~the its~~ response to requests made by Varona in the March 10th cable. Stated that [REDACTED]<sup>U.S. Gov't</sup> would guarantee the entry of key ~~persons~~<sup>leaders</sup> and followers; economic assistance will be forthcoming; working on a long wave radio station, and the establishment of a unified command will be discussed at meeting ~~in~~ in the U.S. with [REDACTED]<sup>? media assets?</sup>, Justo Carrillo, Hernandez and Rubio Padillo.

In a dispatch from the Chief of Station ~~Havana~~, Havana, dated April 1, 1960 it is reported that Santiago Babun called at the U.S. Embassy to see Gerald L. Gardyne. On March 23, 1960 Babun introduced Orlando Accosta and Eugenio Rolando Martinez to Gardyne. Babun said he, Accosta and

Martinez were in close contact with Varona. Babun asked Gardyne if he knew Carlos Casaus who resides in the Fosca building and claims to be a special investigator for <sup>U.S. Govt</sup> ~~[redacted]~~. Gardyne said he did not know Casaus. On March 25, 1960 Gardyne met with Babun, ~~A~~osta, Martinez and Lomberto Diaz Rodriguez.

The dispatch states that Varona probably authorized ~~the~~ Diaz to meet Gardyne in order to cross-check and determine knowledge of Varona's activities are known to the State Dept and <sup>U.S. Govt</sup> ~~[redacted]~~ support.

On April 13, 1960 Varona met with 03 and wanted ~~to discuss~~ when he arrived in U.S., ~~to discuss with~~ to discuss his views on the Cuban situation with someone who could speak for the U.S. Govt. Varona agreed <sup>on April 16</sup> to meet Carrillo in Caracas, ~~on April 16~~, to proceed to San Jose in case Figueres is not in Caracas, to hold conversations with Arango in Caracas. Varona commented that he is close to Figueres and Betancourt.

A cable dated April 15, 1960 from Droller ~~sta~~ reports a meeting with Buthari. Buthari was eager to introduce Droller to Varona and for Droller to arrange a "Varona / Mr. John" meeting. Buthari reported his son was leaving Cuba and could bring with him 8 students who would be briefed by Bender group and sent to hemisphere countries as agitprop types. Droller comments that such a scheme was in line with "our/Phillips thinking."

An April 28, 1960 cable from the Director to [redacted] <sup>16-17</sup> states that Varona ~~is~~ should be informed that [redacted] <sup>U.S. GOV'T</sup> [redacted] officer) Robert Palmer, is prepared to meet him upon his arrival in N.Y.C.

Gerald Droller and Hunt met with Varona on Dec 20, 1960 at "Joe Stonecrab Restaurant at Miami Beach. ~~The~~ memo of contact report states that Varona's scouts had found an isolated piece of land on Andros Island. Varona discarded the idea of using it as a training site for  $\approx$  100 people. Droller makes the comment that: "I would bet even money that he will pursue this aspect unilaterally."

On Nov 29, 1960 there is a ~~report~~ <sup>from the</sup> memo of conversation between Varona and [Edwin A Vallon], [Robert A. Stevenson], [Robert A. Hurwitch] and Frank Devine of the Department of State. Varona had originally requested to see the Asst Secretary, Mr. Mann. Varona requested funds. He stated that Florida law enforcement was getting stricter. Varona was impatient.

Volume 3 of the Varona file covers the dates from  
May 3, 1960 to June 24, 1960

Varona was to be in N.Y.C. on May 4, 1960 and  
would stay at the St. Moritz if he could get reservations.  
Varona planned on leaving N.Y. for Miami on May 6.

On May 5 Varona met with [redacted]<sup>03</sup>. Varona stated he  
planned on returning to N.Y.C. on May 8 or 9 for a meeting  
with other Cuban leaders, including Justo Carrillo, Pasco  
and others. Varona planned on using Amalio Fiallo as  
agit-prop type. [redacted]<sup>03</sup> stated that they did not  
discuss paramilitary subject because it was activity  
which "could best be handled in conjunction with  
private groups, i.e. the Carr-Bender group." [redacted]<sup>03</sup> stated  
that he followed a format which he and Droller had  
prepared during the political part of the discussion.

[redacted]<sup>03</sup> told Varona "that certain activities were not within  
my province but there was a group that I was aware of,  
headed by Mr. Carr (whose name incidentally Varona had  
mentioned to me first), that the group was completely  
reliable and well-intentioned and did have the proper contacts  
with our government and that he should have  
reservations about working with this group." [redacted]<sup>03</sup> used  
name Robert Roger with Varona.

A cable from [redacted]<sup>16-15</sup> dated May 6, 1960 reports  
Eduardo Alfredo Espinosa de los Monteros de Puleta.

settling differences between Arango and Varona.

The memo states that Figueras and Betancourt urged Arango and Varona to join in a united front. Mujal stated he and Rafael Otero had a lengthy meeting with Varona last week (in NYC). It was decided to form the Frente Sindical Revolucionario as an independent entity from FR but with representation on the FRD. A good candidate was Rafael Otero Borlaff who is described as a confidant of both Varona and Arango. <sup>04</sup> ~~[redacted]~~ <sup>Romualdi</sup> said that Mujal had recently seen Spruille Braden again. A May 26, 1960 cable from miami reports on miscellaneous FRD matters. Varona is to go to Caracas on May 27 to issue public statement explaining break with Castro. ~~Goudie~~ Carrillo will go to Mexico June 3 or 4.

In Mexico and Venezuela, Carrillo and Varona will look for suitable real estate for training Commo operators.

Arttime and <sup>o/Ricardo Luis de la Lorie Bals</sup> [~~Goudie~~] are eager to move to destroy sugar fields.

"Nobody seems like our approach at moment." Suggested

Varona prepare a paper and they would discuss at a Licari / Bender / Varona meeting. "Bender might bring

his "military expert" to mtg." Varona and Carrillo again made point re need for immediate action against Trujillo.

Droller would not give word that Licari and Droller favored Trujillo offer "without much more deliberation."

Varona, Carrillo, and Rasco, jointly asked whether FRD could mount anti-Trujillo activities in collaboration certain unnamed Dominicans. Droller said advice would be forthcoming. Varona accepted first monthly payment, \$700 honorarium, from Droller plus \$200 for chauffeur.

A May 31, 1960 cable to Havana states that "deposit of \$15,000 to Varona account being handled through Grupo Bender." (conversion of pesos to dollars)

A June 2, 1960 cable states that at a 31 May meeting Varona had with Manolo Alcalde Incala, who works for Decor International of Miami and is apparently Varona's right hand man.

A June 3, 1960 cable states that <sup>Employee</sup> [Corbuston] called and met Varona June 3. <sup>from Caracas</sup> Asked Varona not to inform Barker of Corbuston contact. Varona agreed to arrange an executive committee meeting for June 8.

A cable - July 2, 1960, from [Mexico City] reports that on June 23 [redacted] and [redacted] interviewed Varona. There is evidence that Varona is under technical surveillance. "Recommend FRD leaders be warned avoid overt U.S. govt contact."

A cable from Droller reports that at the executive committee ~~the~~ meeting, Varona and Carrillo advised that Vargas Gomez had a long session with [William Pawley] in which [Pawley] said that VEEP, RUBOTTOM, Admiral Burke and Cardinal Spellman were backing Rubio group and could not agree on policies of the FRD. Thus 20-25 signatures from prominent Americans are being collected for letter depicting FRD members as promoting Fidelista policies without Fidel Communism. Letter to be transmitted State Dept. via Cardinal Spellman.

On June 13, 1960 a meeting occurred between Cmdr Pons and [Michael M. Maney.] Pons said he had been attempting to recruit crew members for maritime operations.

It was common knowledge in Miami that Varona had the backing of the CIA (according to Pons). It is known that Diaz Tamayo has substantial backing from Americans.

FNU Gutierrez, who works for Varona, offered to obtain a number of LST's for Pons and is also trying to recruit Navy types. Pons met with Varona who asked Pons to join his group. Pons said he would like to meet with Mr. [Abbott] (Dave Phillips) on June 14.

A June 20, 1960 cable reports that on June 17 that [Edward D. Knapman] was introduced to Capt. Eduardo Ferrer. Ferrer arranged for [Knapman] to meet Ramon Ruiz Sanchez Piedad, Varona's brother-in-law. [ ] met Ruissanchez when Varona's wife left Cuba. Station discourages future relationship with Ruiz Sanchez, unless hqs. has view to control Sanchez may become victim of Castro provocation.

A June 23, 1960 cable to [Mexico City] reports that a conference suite ~~is~~ has been reserved at the Commodore for June 28 thru July 5. Droller would like a meeting with Varona before July 3.

On June 27 1960 there was a meeting of [ ] and [ ] Mujal told [ ] <sup>of Romualdi</sup> that he had been told by FBI contacts not to allow his supporters to undertake assassination plots against the Castros, Che Guevara, etc. Mujal feels this puts him on the spot.

A memo for the Chief of the WHD, dated July 1, 1960 reports that Droller had a 2 hr. meeting with Varona in NYC. Droller told Varona that Mr. Burke Hedges "had no place in our operation." Hedges was trying to raise funds from United Fruit Co; Kuhn Loeb, Rhodes & Co; Standard Oil of N.J. & Am. Power & Light Co. memo suggest that companies be instructed "to bar their doors to Hedges."

A July 14, 1960 MAST cable reports that Arttime & Varona have submitted a list of 70 people for candidacy second phase training.

A July 20, 1960 cable from Havana states that on July 19 Dr. Mario del Canal Ferrer, who described himself as principal representative & coordinator for Varona, contacted pol. officer John Topping and wanted discreet contacts with the Embassy as contacts already established through Jesto Exposito Lorenzo & Juan Menendez Tellez were not sufficient.

When Varona left Cuba he introduced [redacted] to Jesto Exposito Lorenzo as his "personal representative" and

A memo dated July 26, 1960 reports a telephone call from Jack Malone to [redacted] Malone reported that Varona had asked Mr. Lowell Tash to visit Andros Island in order to lease 3 or 4 acres of land. Tash will be instructed to go to Andros and report back to Malone. Tash was the former manager of an Am. ranch in Cuba.

A July 28, 1960 cable from MASH reports that Mario del Canal is "head man and general coordinator in Cuba" for Varona's Rescate. Code name = Patricio Menendez Tellez put Varona in touch with [redacted]

A August 4, 1960 MASH cable reports Varona will be in D.C. for ~~Aug~~ Aug 5 meeting with People to People Committee. Will be in N.Y. Aug 6 and will call Droller. Returning Miami Aug 6.

An Aug 10, 1960 MASH cable reports that after Droller / Frente Exec. Com'n. [redacted] meeting Varona stated FRD is not flexible enough Droller is too stingy. Droller told Varona, that Droller group favors Varona as leader. Droller believes it is time to start funding FRD out of agreed \$131,000/month. Beginning Sept. all funding to be handled via [mexi] (Note: pls be sure Hunt has cash and Swiss account available upon his arrival [mexi])

A Sept 10, 1960 cable from Hunt reports that Hunt presented Varona with new organizational plan which Varona accepted. Hunt will work on Rasco to accept plan. Rapport is better than ever.

A Sept 15, 1960 memo reports that Varona arrived in NYC during the early P.M. on September 14 and was planning on staying in N.Y.C. for a period of two days. ~~the~~ On <sup>Sept</sup> ~~16~~ 17 subject was planning to proceed to 115 Venetian Way, San Marine, Florida.

<sup>A</sup> ~~the~~ Sept 16, 1960 cable from MASH reports that Sosa told Droller &  of Varona's strong desire to return to Cuba soon. Droller felt it would be an excellent step.

A Sept 22, 1960 report by Droller reports a meeting of Varona, [ ] and Droller in Coral Gables on Sept 22. Varona discussed the possibility of his return to Cuba. Droller thought it was a good idea for Varona to return to Cuba. Requested a detailed statement from Varona. Varona said he was going to N.Y. on ~~Sept~~ the evening of the 18th.

A Sept 27, 1960 cable from MASH reports that Jerry W. Erler ~~has~~, Pres. of Sears Roebuck in Cuba, has been approached by Manuel Rodriguez to serve as an alternate courier for FRD. Rodriguez said he is the intermediary between FRD & recuperacion in Cuba for mutual support coordination both groups. He travels Havana-miami 3 times/month and meets Frank Zayas and/or Tony Varona to give & receive plans & instructions.

A Sept 29, 1960 cable reports that on Sept 27, Varona was appointed general coordinator of FRD.

A Sept 30, 1960 memo by Droller reports on a Sept 27 meeting with Varona at the La moderne motel, Coral Gables. [ ] & Droller met & Varona brought Droller up to date on events which had taken place after his return <sup>with</sup> Carrillo from meeting with Hunt & Droller in Washington.

Varona reported that a high-level <sup>official</sup> American had recently come through Miami and had spoken to [William Pawley]. An agreement was reached between this Am. & [Pawley] that the ~~Exec. Comm~~ <sup>Exec. Comm</sup> would be replaced by Rubio Padrillo & Co.

Vol Five of the Varona file covers the period from Oct 1, 1960 to Dec 30, 1960.

An Oct 3, 1960 memo reports a meeting with Varona, ~~Caplan~~, & Droller on Sept 28. Varona stated that Goudie & Elena felt bad about Jim Smith dealing over their heads. Droller told Varona that "we would send in the future certain equipment into Cuba. If everything went well, I would inform him and the FRD could take the credit. If something went wrong, the FRD, however, would have to take the blame.

An Oct 5, 1960 from JMMASH reports meeting of Hunt & Varona. Agreed that Hunt will maintain normal contacts with Varona and other ~~At~~ <sup>FRD exec comm.</sup> members plus Sosa and ~~Paula~~ Paula. Also has right to discuss opns with departmental chiefs Fravel & Brown and ~~Smith~~ will confine contacts to departmental Chiefs plus Sosa. Also, no ~~us~~ American should make commitments to any Cuban without consultation with Varona. "Believe above reasonable. . . . However, in practical terms none of above intended curtail current production or relationships."

An Oct 6, 1960 cable reports that Varona stated that 2 Cuban pilots and navigator who fly Castro on International flights are ready to defect & "FYI: If pilots really fly Castro this opens other opnl possibilities."

An Oct 8, 1960 cable reports that Hunt, via Barker, is becoming familiar with working level of FRD matters and "this will provide a SECRET on Varona's activity

and performance."

An Oct 5, 1960 MASH cable reports that Hunt should remind Varona of agreement reached with Bender whereby [redacted] retains control and funding of FRD affiliates."

An Oct 8, 1960 Mash cable (Action, Mr. Phillips) states that Varona is interested in mounting P.M. ops as political favor for contacts with non-FRD supporters who are desirous utilize Varona's access to arms source. Sosa has made 2 approaches to <sup>Fravel S. Brown</sup> ~~[redacted]~~; Varona want to use Alberto Fernandez Echevarria and Nino Diaz. Sosa claimed that Varona is in contact with an unnamed individual who owns a small plane which has made two flights from Florida in last 2 wks to make arms delivery to Duque group in Escambrey.

"Basic element of interest above is Varona's willingness break own FRD administrative channels."

An Oct 12, 1960 cable reports from IMMASHIT reports that the DRE has selected students for first propaganda team: Ramon Barquin Canterio, Carlos de Varona, Miguel A. Garcia Armengo, Manuel Salvat Roque, Alberto Muller y Quintana.

Alberto Roque may use alias Tue Castell.

A contact report by Droller dated Oct 17, 1960 reports a meeting with <sup>by Romauldi</sup> ~~[redacted]~~ on Oct 12. <sup>OL Romauldi</sup> ~~[redacted]~~ said he is to have a meeting with Varona and hoped ~~FRD~~ M&R's entry into FRD would be accomplished soon. Requested assistance to infiltrate one of his men, FN U CRESPI.

An Oct 17, 1963 contact report by Droller of a meeting with Martinez Fraga on Oct 13 reports that Fraga was to go to Paris on Oct 14 to persuade Alonso Pujol "to return to the U.S. in order to begin and carry out the important work of a "behind-the-scenes" collaborator with FRD. Droller approved, as did Varona.

An Oct 18, 1960 contact report by Droller reports a meeting with Varona. Varona requested arms be supplied and that we not inquire into the details of how he would dispose of them. Made other requests. No commitment given.

An Oct 19, 1960 cable reports that Varona has been rebuked for Oct 17th raid and on Oct 18 Hunt told Varona that material still unaccounted for. Varona began taking steps to recover. ... No reason to believe any key materials purposely withheld..."

An Oct 20, 1960 cable from MASH reports that C. Gsmunt moody said that [Pawley] had called him and told him to contact Varona who was to contact his CIA contact. [Pawley] said his instructions come from "JAKE,"

A Dec 19, 1960 WAVE cable reports that per [Sgorgory's] (employee) verbal query at WAVE, Rafael ("Macho") Genor working with FRD. Varona approves visa for wife.

A Dec 19, 1960 cable from Havana reports lengthy meetings with ~~XXXXXXXXXX~~ <sup>Ramon Augusto Ruiz Sanchez</sup>. Disillusioned with FRD and Varona.

A Dec 19, 1960 dispatch reports that Jose Joaquin SanJenis Perdona reports that Gisela Garcia de Solis, who resides at 314 L. St., Sparks, Nevada is the wife of Roberto Solis who works at the Hotel Riverside in Reno, Nevada. She is working for FRD in Nevada, LA, San Francisco, Reno, and Las Vegas. Recommended for job by Varona and Pujol.

Vol 6 of the Varona file covers the dates from January 61 to May 31, 1961.

Lauderdale, is engaged in the production of explosives and he now has a new type he wishes to make known to the U.S. Govt. Currently engaged in filling a large order for Cubans. Gave names: Varona, Frederick Goudie, Florentine Blanco, Aguelera. Grills is in business with Lewis O'Connor and Joseph O'Connor.

A January 13, 1961 memo for the record reports a conversation between Barker and Varona concerning the Cuban exile group's visit to Washington. Varona said there were plans to thank Eisenhower for the million dollars for Cuban exile relief, to visit Peruvian Amb. to U.S., and to speak to reps of the OAS. This is a follow-up of approach by Manuel Brana to a Mr. White and Mr. Hopkins who are associated with the White House. Varona's rep in N.Y. is Eduardo Gonzalez.

A memo for the record, dated Jan 23, 1961, by [Michael M. Maney] reports that "In a telecon with Francisco Saralegui (Bohemia Libre) on this date, he confided to me that he had been told by Lopez Fresquet of a conversation which Lopez had had with the President on Saturday. He was promised that once a beachhead was established in Cuba, a provisional govt should be set up constituted by Rulo Lopez Fresquet, Mico, and Varona. A Feb 28, 1961 ~~re~~ memo by Droller states that Droller and Napoli met with Varona on Feb 17. On the same day they had a meeting with both Varona and Ray. Droller presented a list of 29 names from which they were to choose 10 for the provisional govt. Ray became upset. Also gave them a 7 point program as discussed with the Chief of the Western Hemisphere Division. It was agreed that Varona <sup>& Ray</sup> would <sup>go</sup> ~~return~~ to ~~Washington~~ NY on Feb 26 to meet with Artime, Carrillo, Chibas & Pazos and decide on names. A May 15, 1961 dispatch reports that 2 cans of exposed 35mm film taken from files confiscated from Varona's Radop are being sent. Requests develop film.

A memo by Droller, dated June 9, 1961 reports a luncheon meeting with Cardona and Ernesto Aragon at the Mayflower Hotel. Miro reported re meeting of Miro, Varona, and Aragon with Goodwin and Mr. Schlesinger, who professed confidence in Miro. Miro gave

A June 12, 1961 dispatch reports a rumor in Miami that Varona has over \$300,000 deposited in an unidentified bank in Miami. The source of funds is unknown.

A June 14, 1961 cable reports that Arttime is setting up 5 rendezvous points about 5 miles outside Havana Harbor for exfil/infil ops.

A July 7, 1961 memo by Droller reports on payments made to Varona. Varona is being paid \$900/month. Varona was promised by <sup>03</sup> [ ] that he would receive support for operational plans and personal needs. Mzy 20, 1960 - payments were discussed at Hdq. 200 was to go to chauffeur - Francisco Zayas. Paid by Bender check - June 1, 1960 - Nov 1960.

From Nov 1960 to March 1961 - paid directly in cash by Hun April & May 1961 paid by Bender check from Hdq.

Payments were in addition to salary from FRD. "As of July 3, 1961, I was of the opinion that we should not pay Varona anything more under the table, but in view of the Special Group decision, if I am correctly informed, of encouraging our dealings with numerous Cuban groups and personalities it might be wise to keep in touch with Varona for some time and pay him some reasonable amt as nothing cements friendships better than money." Routing Slip contains remark that we should hold off. Varona is one of most bitter critics. "I don't ~~prop~~ propose to buy him off."

On July 7, 1961 Varona called the CIA. [redacted] has been designated as replacement for Jerry Droller in liaison matters with Cardona.

A July 10, 1961 dispatch reports that Major Robert E. Van Horn USAF, assistant air attache to Cuba assigned to the miami area to be liaison with Cuban pilots in miami.

A July 7, 1961 memo for record by [redacted] reports a contact with Varona. Varona is in D.C. staying at the Roosevelt Hotel. He will be in D.C. for three or four days. [redacted] used name of Raymond Clark. Varona asked several questions re state of affairs, but received no answers. Asked how to get in touch with Gen. Taylor and was told to go through Mr. Goodwin

On July 11, 1961 Varona requested money for 3 prisoners who were stranded at the marriott. Answer: NO.

Tarabochia held over 2 hr. conversation with Varona. Report from Miami.

A Sept 9, 1961 cable from miami reports the CRC and the FRD will merge around Sept 15. Miro will be head and Varona second.

A CRC meeting was held on Oct 9, 1961 in NYC & Varona was present. Varona visited San Jose on Aug 17, 1962. On Aug 15, 1962 Varona visited President Roberto Chiari of Panama and requested a meeting of central American chiefs of state on Cuban issue. Rumor in Miami that efforts are being made to convince President Chiari to permit the establishment in Panama of Cuban govt in exile. On Aug 24 Varona returned to Miami.

On Oct 31, 1962 Varona had a meeting with Hurwitch in Washington.

On Dec 2, 1962, Varona met with Pres Morales of Honduras and several other leaders of Cuban group. Varona made a lengthy statement that the CIA was responsible for the current lack of activity and that the CIA was working behind back of Kennedy.

It contains answers to questions 36 thru 58 on Varona's PRQ II. Varona was first introduced to Palinger in May 1957. [Wallace A. Growery] Varona's case officer. Varona was classified as an "indigenous field agent."
