ReButel instructed all offices to contact
informants and to establish whereabouts of racial extremists,
etc.

In accordance with Bureau instructions, all
security, racial and criminal informants were contacted
concerning this matter with negative results. In addition,
whereabouts of bombing suspects of known klan and hate
group members, known racial extremists and all
individuals, who on basis of information available in the
Little Rock files who may possibly have been involved,
was established on 11/22/63. All individuals within the
Little Rock Division were accounted for.

The identities of the informants contacted
and the individuals whose whereabouts were checked out will
not be set forth in this communication; however, a complete
record is being maintained in the Little Rock file.
