In order to assist the U. S. Secret Service in determining possible danger spots in connection with its function of protecting the President, the Vice President and members of their families, particularly with regard to travel by the President, it is desired that copies of letterhead memoranda containing specific information concerning possible violence in connection with bombing matters, general racial matters and Klan and hate groups be disseminated to the local Secret Service office covering this territory. A notation to the effect that this has been done should appear in the cover airtel submitting the letterhead memorandum to the Bureau.
