Facts of complaint C. stated he is employed in Quality Assurance Dept. of Hydraulic Research Co., 3540 Naomi St., Burbank, Which is under Air Force Jurisdiction.

About  $l\frac{1}{2}$  to 2 weeks ago one of the engineers in the same building with complainant was noticed to have a rifle at work which, according to complainant, was similar to the rifle used by LEE OSWALD to kill President Kennedy. Complainant states that this engineer was working on the rear sight and the bolt lever of the rifle during his lunch hour. C. has seen this engineer previously with another rifle and has heard several of the employees discussing rifles. They talk about target shooting.

C. stated he doesn't know this Engineer's identity, but same could probably be ascertained from a Mr. Pace, who is head of the Quality Assurance Dept. C. described the Engineer as a male, caus., about 27-30 yrs., dark complex., dark hair, 5'10 or 11", and of foreigh extraction.

c. felt that he should furnish this info. to FBI if same was of interest.
