Interview:

On 3/12/78 Staff Investigator Harold D. Leap interviewed former FBI Agent John L. Quigley at his residence, Apt. 101, 1823 Embassy Dr., West Palm Beach, Fla. relative to the JFK assassination investigation being conducted by the SCA.

Present at the interview, at the request of Mr. Quigley, was his attorney Moross Irving. Mr. Quigley asked that the interview not be recorded and asked if he and Mr. Irving could review my handwritten notes before I left.

Mr. Quigley stated that he had no additional information to add to his Warren Commission Testimony, or his affidavid dated 7 February 64 concerning the Oswald-F.B.I. informant issue.

Investigator Leap advised Quigley that he had several questions which he would like to ask even though they may be some what repetitious of his previous testimony. Quigley agreed to answer any question that he could.

- Q. Who took the telephone call at the FBI office relative to Oswald's interview request of 10 August 63?
- A. I don't remember.
- Q. Could it have been William Walter?
- A. I really don't remember. It has been 14 years.

 It would not have been Walter. It would have been an Agent.
- Q. Usually when a defendant asks for an interview, he wants something for the information he will provide: money, help on a pending charge, revenge. What was Oswald's motive for the interview request?
- A. I really do not know.
- Q. Did you ask Oswald what he wanted?
- A. No.
- Q. Why would anyone bring himself to the attention of the FBI if he was engaged in communistic activity in the U.S.?
- A. I cannot answer the question.
- Q. Did you do a name check at the FBI office after the interview?
- A. Yes.

- Q. What did the indices reflect?
- A. Security Investigation assigned to Kaach
- Q. Did the indices reflect an informant number?
- A. No. if Oswald had been an informant I would have known it.
- Q. Are you aware of the allegation made by William Walter?
- A. I am and I can state there is no truth to his statements.
- Q. What statements?
- A. That the FBI received a teletype on November 17 that JFK would be killed in Dallas on November 22 and that Oswald was a FBI informant.
- Q. Why do you think Walter is making the allegations?
- A. I don't know.
