AT BOSTON, MASSACHUSETTS. Will place appropriate stops with United States Customs Office, Boston, in regard to the reentry into the United States of GUS ALEX and his paramour, SUZANNE FUEGER, who will probably be returning to the United States from Europe the first week of February, 1964. It is requested that both be stripped searched by customs officials to ascertain if either is carrying large sums of money or possibly photographic material. In all probability ALEX and FUEGER will return to the United States on separate flights and on separate dates.

It is to be noted that last year ALEX returned from Europe through United States Customs at Boston, at which time movie film was confiscated from ALEX and subsequently made available to this office.

AT CHICAGO, ILLINOIS. Will continue to conduct and report investigation concerning the background and activity of GUS ALEX in accordance with Bureau letter to Newark dated November 27, 1957, entitled "TOP HOODLUM PROGRAM, AR."

WILLIAM JAMES, TWA, advised on December 5, 1963, that SUZANNE FUEGER using the name of DIETGARD FUEGER departed from O'Hare International Airport at 3 p.m. on TWA flight 800 enroute to Paris, France and Munich, Germany traveling alone. Her plane was scheduled to arrive Idlewild Airport, 5:53 p.m. where they will have a short layover and depart from Idlewild 7 p.m. via TWA to Paris. It is to be noted that in all contacts with WILLIAM JAMES no record of any reservations was found for GUS ALEX. In this connection it is believed that he was planning to travel to New York City by domestic airlines and thereafter leave from New York for Paris on an unknown overseas airlines.

Munich, Germany Police advised that they had received information from the West German Federal Criminal Police that DIETGARD FUEGER had arrived in Munich, Germany on December 6, 1963, as scheduled where she was met by her mother, ELROSE FUEGER. West German Federal Criminal Police also advised that SUZANNE and her mother were staying at the Bayerischerhof for three days. FUEGER was not known to have been contacted by anyone outside of her mother during this three-day stay in Munich. The West German Federal Criminal Police further advised that SUZANNE and her mother left the above named hotel at about noon on December 8, 1963, enroute to Riederau.

SUZANNE informed the management of the hotel of the loss of a platinum chain with a heart shaped locket containing diamonds of approximately three karats. FUEGER did not make a formal complaint or report the theft to the police. Instead she advised the hotel employees that she would first check at home in America to see if she left the jewelry at home. West German Federal Criminal Police advised that ALEX was not observed in Munich.

A member of the Police Judiciaire (criminal police), Surete Nationale, arrived at Orly Airport, Paris, France, at 8:25 a.m., December 6, 1963, and departed at 9:05 a.m. the same date enroute to Munich, Germany. FUEGER remained "in transit" and therefore there is no official record of her having entered France on that date.
