PCI GLADYS EBLE advised on 11/29/60, that GIANCANA, accompanied by several other unknown males, were at the Armory Lounge on that date for a brief period. GIANCANA was driving a 1959 Ford Galaxie bearing 1960 Illinois license 2431761. (u)

CG 6379-C advised on 11/30/60 that he had again been approached by CHARLES NICOLETTI and WILLIAM DADDANO regarding the previous proposition by this group for the informant to act in some sort of a courier capacity on Monday nights for them. Informant advised, however, that he has been ordered by his doctor to become hospitalized during the latter part of this week for an unknown heart condition which will probably incapacitate the informant for several weeks so that the proposed project being undertaken by the informant will have to be delayed. (u)

With regard to the Armory Lounge it should be noted here that the owner of the Armory Lounge, CARMEN FANELLI has become the subject of a perjury case resulting from his testimony in the recent trial of ANTHONY ACCARDO. (u)
