The interview had with CANNAROZZO on 3/27/59 does not appear on an FD 302 but is located on Page 4 of the report of SA FRANCIS B. JENKINS, Buffalo, 5/11/59 in the case captioned "RICHFORD OPERATING CORPORATION, ETAL; JAMES VINCENT LA DUCA - FUGITIVE, LMRA - IM" BU File 92-3054.

The indices of the Buffalo Office also indicate that PATRICIA CARLSON, nee Archer, DOB 7/8/31, Randolph, NY, was a Confidential Source of the Buffalo Office in security matters in 1954 and 1955, being discontinued 3/21/55. BU File in this case was 134-3300. It is not known if she is identical with the PATRICIA ARCHER listed in the enclosure to ReBUat of 10/22/59.
