SAMUEL M. GIANCANA, AKA, AR. DAILY SUMMARY.

MIAMI ADVISED THAT RICHARD BURNS, AKA, BERNAS, LESTER KRUSE, AND ANOTHER UNIDENTIFIED INDIVIDUAL BELIEVED TO BE KRUSE/S SON WERE IN LAKE WORTH, FLA., DURING WEEK OF JUNE THIRTEEN LAST IN CONNECTION WITH INSTALLATION OF CENTRAL HEATING AND AIR CONDITIONING AT THE LAKE WORTH, FLA, RESIDENCE. GIANCANA NOT KNOWN TO BE CONNECTED WITH THIS VISIT OR JOB. KRUSE ARRIVED IN FLA. WITH A CASHIER/S CHECK FOR FOUR THOUSAND DOLLARS MADE TO MERCHANTS NATIONAL BANK, CHICAGO. CASHIER/S CHECK MADE FROM SAME BANK USED TO PAY MORTGAGE OF FIVE HUNDRED SEVEN DOLLARS ON RESIDENCE DATED APRIL THREE, SIXTY ONE. INQUIRY BEING MADE AT MERCHANTS NATIONAL BANK TO ASCERTAIN MAKER OF THESE CASHIER/S CHECKS. LOS ANGELES ADVISED THAT A CHECK OF A TOLL CALL MADE FROM THE LAKE WORTH RESIDENCE TO LOS ANGELES, CALIF., NUMBER CR SIX ZERO ZERO THREE TWO REFLECTS THIS NUMBER IS THE UNLISTED NUMBER OF FRANK SINATRA. KEELY SMITH WAS INTERVIEWED AT HOLLYWOOD, CALIF., JUNE TWENTY LAST, AND ADVISED THAT SHE HAD BEEN INTERVIEWED BY AND FURNISHED AN AFFIDAVIT

TO AGENTS OF THE INTERNAL REVENUE SERVICE IN SEPT., SIXTY, DURING WHICH SHE HAD ANSWERED A NUMBER OF QUESTIONS RELATING TO HER DEALINGS WITH GIANCANA AND SAID THAT SHE HAD NOTHING FURTHER TO ADD TO THE AFFIDAVIT. SHE SAID SHE WILL CONTACT HER ATTORNEY, FURNISH A COPY OF THE AFFIDAVIT TO THE INTERVIEWING AGENTS AND IF NECESSARY, FURTHER ELABORATE ON THE ANSWERS. SHE DECLINED TO FURNISH ANY INFO, HOWEVER, UNTIL SHE HAD A CHANCE TO PERUSE THIS AFFIDAVIT. SHE SAID THAT SHE HAS HAD NO DEALINGS WITH GIANCANA WHATEVER SINCE BEFORE SEPT., SIXTY, AND DENIED RECEIVING ANY GIFTS FROM HIM AT ANY TIME. CG SIX FOUR FIVE SEVEN DASH PC ADVISED SHE HAS HAD NO CONTACT WITH DOMINICK BLASI OR GIANCANA, HOWEVER, SHE HEARD FROM HER NEIGHBOR, ONE MICHAEL ACERRA, WHO IS A FRIEND OF GIANCANA, THAT GIANCANA NOW HAS A NEW GIRL FRIEND, AND HE HAS BEEN TO ACERRA/S HOUSE RECENTLY WITH HER. PCI GLADYS EBLE ADVISED THAT SHE HAS NOTED A NEW FEMALE ACQUAINTANCE OF GIANCANA IN A FORD AUTO, LICENSE NO. GE ONE ONE SEVEN ZERO, AS RECENTLY AS LAST WEEK. THIS NO. CHECKS TO ONE EDWARD SISCO, ONE ONE SEVEN ZERO S. LYMON, OAK PARK, ILL. FURTHER INQUIRY BEING MADE RE THIS. INVESTIGATION CONTINUING. ARMED AND DANGEROUS. 4
