SAMUEL M. GIANCANA, AKA, AR. DAILY SUMMARY. LAS VEGAS ADVISED BY  
TELETYPE YESTERDAY THAT CONFIDENTIAL SOURCE ADVISED STRONG POSSIBILITY  
OF SUBJECT BEING IN LAS VEGAS AT GREEN GABLES RANCH WITH PHYLLIS MC  
GUIRE, HAVING BEEN THERE FOR PAST FEW DAYS. INDIVIDUAL RESEMBLING  
GIANCANA STAYS IN HOUSE AND AVOIDS CONTACT WITH OUTSIDERS. MC GUIRE  
WAS OBSERVED SUNBATHING IN THE NUDE WHILE PERSON RESEMBLING GIANCANA  
SPRAYED HER WITH GARDEN HOSE TO KEEP COOL. ONE CAR OBSERVED AT  
RANCH ON NUMEROUS OCCASIONS, LISTED TO NICKOLAS CECOLA, TWO TWO ZERO  
SOUTH FAIRFIELD, LAS VEGAS. LAS VEGAS ADVISED THAT APARTMENT AVAILABLE  
FOR OBSERVATION POST AVAILABLE ADJACENT TO MC GUIRE/S RANCH HOUSE.  
RE NICKOLAS CECOLA, CHICAGO INDICES REFLECT ONE NICHOLAS CECOLA, NOT  
FURTHER IDENTIFIED, AS ASSOCIATE OF DECEASED CHICAGO HOODLUM TONY  
CAPONE IN THE FORTIES. ONE NICHOLAS JOSEPH CECOLA, RECORDED  
COURT DEPUTY, CHICAGO, AND CO OWNER OF BAR IN CHICAGO, INTERVIEWED  
IN NINETEEN FIFTY NINE BY BUAGENTS RE A PERJURY CASE IN WHICH HE

WAS POTENTIAL WITNESS. THIS CECOLA DESCRIBED AS FORTY FIVE YEARS OF AGE, MARRIED WITH THREE CHILDREN. PRETEXT CALLS MADE TO CECOLA RESIDENCE AND BAR ASCERTAINED THAT CECOLA, AS OF INSTANT DATE, IS IN CHICAGO. PCI GLADYS EBLE ADVISED INSTANT DATE SHE HAS OBSERVED DOMINICK BLASI AT ARMORY LOUNGE ON SEVERAL OCCASIONS DURING PAST WEEK, BUT HAS NOT OBSERVED GIANCANA. CG SIX FOUR FIVE SEVEN DASH PC ADVISED INSTANT DATE SHE MADE PRETEXT CALL TO BLASI YESTERDAY, AND ASCERTAINED THAT GIANCANA IS OUT OF TOWN, WHEREABOUTS UNKNOWN TO INFORMANT. INVESTIGATION CONTINUING.
