On 1/7/63, ROSSELLI deposited \$4500 to his account at Fidelity Bank, Beverly Hills, California. This was a check drawn on the account of LOUIS J. LEDERER at the Exchange National Bank of Chicago, Illinois and was for payments of \$750 per month for first six months of 1963 owed by LEDERER to ROSSELLI for sale of Nevada Concessions, Inc. in 1958.

ERNEST LE BLANC, steam room attendant, Friar's Club, Beverly Hills, interviewed as source of information regarding ROSSELLI's activities at the Friar's Club and agreed to cooperate.

On 1/29/63, PCI GEORGE COSTELLO, owner, Actor Dial Answering Service, Hollywood, California, made available messages left for BARBARA BARRETT, a girl friend of MAURICE H. FRIEDMAN, part owner of the New Frontier Hotel, Las Vegas, Nevada. On 1/22/63, BARRETT received a call from "Mr. FRIEDMAN, care of Mr. HELLERMAN, Apt. 120" at telephone number CR 4-7777, which is the Beverly Hilton Hotel, Beverly Hills, California. HELLERMAN probably identical with the M. HELLERMAN with whom ROSSELLI travelled to Las Vegas on 1/23/63.
