On 9/22/64, former LA 4476-PC advised that about 11:00 pm. on 9/19/64, he observed ROSSELLI and an unknown man at Dino's, a Sunset Strip night club. He described the unknown man as about 45 years old, 6'2", 175 pounds, and had a mustache. Source said he thought the men were by themselves.

On 9/23/64, BETSY DUNCAN, PCI, advised that the man with ROSSELLI at Dino's on the evening of 9/19/64, was Mr. LEFF who has some ownership in the New Frontier Hotel in Las Vegas. DUNCAN advised that the two men were accompanied by Mr. LEFF and by ROSSELLI's red haired girl friend, KATHY. LEFF is IRVING J. LEFF, who is known to be a friend of ROSSELLI and who lives in the same apartment house as does ROSSELLI.

The Los Angeles Police Department has furnished a copy of the report of the theft of KATHY HORDEN's 1964's Pontiac. The car was stolen from the apartment garage and taken to the vicinity of 151 East 61st Street, Los Angeles, where it was stripped and then set on fire. ROSSELLI claimed that a set of men's golf clubs valued at \$500 was taken from the car and a set of women's golf clubs, valued at \$100. KATHY HORDEN, the registered owner, stated she was a student by occupation and J. ROSSELLI was her boy friend.

ROSSELLI told the Los Angeles Police Department Officer that his business telephone number was 651-0751. Lt. PHILLIPS, LAPD, advised that this number is listed to EMANUEL ROTHMAN, Suite #1104, 6380 Wilshire Boulevard, Los Angeles. It is noted that the address of ROTHMAN's firm is 7959 West 3rd Street, Los Angeles, and it was not previously known that he had another office at the Wilshire Boulevard address. Lt. PHILLIPS further advised that HORDEN received two traffic citations from the LAPD during the month of May, 1964. On one of these occasions, she was driving a Volkswagen, bearing Nevada license CB 6804, which was registered to her at 2908 Burton Street, Las Vegas, Nevada.
