VENEZUELAN AUTHORITIES HAVE SUCCEEDED IN EXPANDING CORUS FROMISE TO REFRAIN FROM TERRORIST ACTIVITIES NOT ONLY IN VENE-ZUELAN TERRITORY BUT IN COSTA RICA AS WELL. IN EXCHANGE, CORU LEADERS WILL BE ALLOWED TO TRAVEL TO VENEZUELA FREELY TO SOLICIT MONETARY ASSISTANCE FROM CUBAN EXILES, BUT THEY ARE NOT TO UTILIZE THE COUNTRY AS A PLACE OF REFUGE OR A BASE OF OPERATIONS.
