Proposed Investigation

NYO will continue to assess PITTMAN's policy-making and leadership role in the CPUSA and will remain alert to develop any information indicating covert intelligence activities, foreign travel, espousal of [criteria country] propaganda, and contacts with Soviet's or other [criteria country] nationals which might confirm his role in the spread of international communism. (S)

Although PITTMAN is a member of the Central Committee, CPUSA, investigation to date has not produced any evidence that he has been actively involved in the policy making process or that he has provided any leadership for the CPUSA since his assignment overseas in 1974. Accordingly, NYO hereby downgrades investigation of the subject [from Category II to Category III]. (S) (C)
