GABRIEL MANNARINO, AKA, AR, SAMUEL MANNARINO, AKA, AR. IT IS NOTED THAT ON AUGUST FOURTEEN AND FIFTEEN LAST, JOSEPH R. MEROLA, MIAMI, FLA., ADVISED QUOTE THE OUTFIT UNQUOTE COMPELLED KELLY MANNARINO TO TAKE TEN THOUSAND BOOKS OF PAN AMERICAN SWEEPSTAKES TICKETS FOR DISTRIBUTION IN WESTERN PENNSYLVANIA. AN INFORMANT HAS ADVISED THAT ONLY TWO NUMBERS WRITING ESTABLISHMENTS IN NEW KENSINGTON, PA., FEATURE THESE TICKETS, PHYSICALLY DISTRIBUTED BY MANNARINO-S EMPLOYEE JOHN CIRIGLIANO, AKA SHIRGGS. ANOTHER INFORMANT ADVISED HE BOUGHT TICKET ON AUGUST THIRTY ONE LAST IN TARENTUM, PA., AND ON SPETEMBER ONE INSTANT, ANOTHER INFORMANT ADVISED OF PRESENCE OF THESE TICKETS IN PITTSBURGH, PA., FOR PAST TWO OR THREE WEEKS AT VARIOUS NUMBERS WRITING SPOTS. BOTH SUBJECTS SHOULD BE CONSIDERED ARMED AND DANGEROUS.
