ReRomelet to Bureau 4/26/63.

On June 12, 1963, Dr. Aristide Manopulo, Central Bureau, Criminal Division, Italian National Police, Rome, Italy, advised that Italian Police investigation has failed to develop any additional information concerning subject's travels and activities while in Italy. He stated Italian Police sources have been alerted and should any information be received he will immediately notify the Rome Office.

For the Bureau's additional information, on June 6, 1963, the American Consulate General (ACG), Palermo, Sicily, Italy, advised that Calogero Sinatra appeared at the Consulate General on June 4 to request revalidation of his non-immigrant B-2 visa which was issued at Palermo on April 17, 1962, and used for one entry into the United States on June 16, 1962. According to the ACG, the visa file which was initiated when Sinatra made his original application was forwarded to the American Embassy in Rome in August, 1962, and had not been returned to the ACG. The ACG stated Sinatra indicated he wished to depart from Italy on June 10, 1963, but was informed by the ACG that it would be impossible to make a decision on his request by that date.
