According to Dr. SISO, MENDIZABAL is presently exercising her amorous inclinations on a Miami Beach attorney by the name of JACK LIPMAN, whose office is located at 605 Lincoln Road, Miami Beach, Florida.

In view of the above, the Miami Office does not contemplate additional investigation of the subject. However, the Miami Office will be constantly aware and alert to any information which would involve the subject in any Cuban activities in the Miami area which would possibly constitute a violation of the Registration or Neutrality Acts.
