A former Connecticut police officer who is Office Manager for a car rental agency servicing major Miami Beach, Fla. hotels, and through this employment, has contacts with criminal element.

Supervisor of an agency which conducts credit investigations and can obtain info as to financial and business interests of hoodlums and racketeers.

An attorney and former member of law firm of LOPEZ, MUNOZ and CASTELLANOS, Havana, Cuba, now a Cuban refugee in Miami, Fla., whose identity is concealed at his request.
