On February 2, 1959, the following information was received from the Salt Lake City Office:

On December 18, 1958, Mr. WILLIAM SINNOTT, Member Nevada Gaming Control Board, Carson City, Nevada, confidentially advised that the Board had no record of an application by the subject or information to indicate that he intended to apply for a license to operate or buy an interest in a gambling casino in Nevada.
