MM T-1 is JESUS RAFAEL FRANCO CANEDO, 68 SW 11th St., Miami, who furnished the info to SA JOSEPH P. MC CANN on 7/3/63.

Info obtained from the informant on 7/3/63, to the effect that LUIS BALBUENA had not made the trip to New York he had planned was orally furnished to WALLACE SHANLEY, Agent in Charge, Enforcement Division, U.S. Customs, Miami, Fla., due to his interest in this matter. SHANLEY was also furnished info set out in enclosed LHM. SHANLEY requested we continue to advise him of developments in this matter.

The info in the LHM is being appropriately paraphrased in order to protect the informant. The LHM is also classified "CONFIDENTIAL", to further protect this informant, a source of continuing value whose life might be jeopardized if his identity were disclosed.

An info copy of instant LHM is being forwarded to the New Orleans, New York and San Juan Offices, because of their interest in subject organization.
