PHOENIX TELETYPE TO NEWARK TODAY STATED SAN FRANCISCO HAD ADVISED JOSEPH BONANNO IN SAN FRANCISCO ON AUGUST TWENTY THREE LAST AND PLANNING TO RETURN TO TUCSON THIS WEEK END. BONANNO HAD NOT RETURNED TO TUCSON.

SAN FRANCISCO SUBSEQUENTLY ADVISED NEWARK THAT JANET FISYR, PCI, TODAY ADVISED THAT CATHERINE GENOVESE, DAUGHTER OF JOSEPH BONANNO, STATED TODAY THAT HER PARENTS HAD LEFT SAN MATEO, CALIFORNIA TWO DAYS AGO BY CAR AND INDICATED THE BONANNOS WERE RETURNING TO TUCSON. SAN FRANCISCO SUGGESTED THE POSSIBILITY EXISTS THAT THE JOSEPH BONANNO REFERRED TO BY NEWARK MAY BE IDENTICAL WITH JOSEPH BONANNO, JR.
