On February 3, 1971, PCI HUCTOR FIGUEROA advised that he did not know either PARKS or SHARPIN to be involved in prostitution activities in the area.

On February 5, 1971, PCI LEON ROSENBAUM advised that he was not acquainted with either PARKS or SHARPIN.
