On 7/8/59, PAUL J. RENNARD (PH-525-C) was contacted by SA FREDERICK T. HOULIHAN, at which time informant advised conditions have not changed and reiterated his fear of losing his job as a pilot for LOUIS PAGNOTTI, SR., should his identity be revealed, which he feels would also result in his being black balled as to future employment.

RENNARD stated he has not furnished information to any other government agency and has not been approached or received a subpoena to appear as a witness.

With regard to how or where the Department obtained informant's name, it is noted in paragraph one, page four of letterhead memorandum dated 6/25/59, reflecting interview of 1/3/58, RENNARD was interviewed by a member of the Pennsylvania State Police prior to being originally contacted by the Philadelphia Office.
